The Bank of New York has announced that there will be a cash distribution in the NASDAQ-100 Index Tracking Stock ("QQQQ/QIQ/QAV/QQQ/QUE/YQQ/QVO/WD/YWZ/OZC/VCQ/VUK"), a portion of which will reflect the Microsoft Corporation ("MSFT") \$3.00 special cash dividend. The distribution attributable to the MSFT special cash dividend will be **\$0.34592** in cash per QQQQ share held of record December 21, 2004. The payable date is December 31, 2004. **The ex-date for the distribution will be Friday, December 17, 2004.**

Contract Adjustment

Pursuant to Article VI, Section 11 of OCC's By-Laws, all QIQ/QAV/QQQ/QUE/YQQ/QVO/WD/YWZ/OZC/VCQ/VUK options outstanding as of Friday, December 17, 2004, shall be adjusted to reflect the cash distribution attributable to the MSFT special cash dividend by decreasing the strike price by \$0.34592, the amount attributable to the MSFT special cash distribution (rounding the result to the nearest eighth of a dollar).

Note: **** The option symbols for the adjusted contracts will change to QBI, QAI, QQC, QBD, QBF, QAD, WQC, YIZ, ODH, VQG or OHF, as the case may be.

Premiums and strike-price amounts for the adjusted QBI/QAI/QQC/QBD/QBF/QAD/WQC/YIZ/ODH/VQG/OHF options will continue to be calculated on the basis of a multiplier of 100, i.e., for premium and strike-price extensions, 1.00 will equal \$100. [Any FLEX series that may exist will be adjusted in a similar manner to the standardized option.]

On Friday, December 17, 2004, trading in QIQ/QAV/QQQ/QUE/YQQ/QVO/WD/YWZ/OZC/VCQ/VUK series will be on an adjusted basis. At 8:30 A.M., Chicago time, an opening rotation will be effected with the following adjustments:

GTC Order Conversion

On Thursday, December 16, 2004, immediately after the CBOE close, the system will convert or cancel all resting orders in the QIQ/QAV/QQQ/QUE/YQQ/QVO/WD/YWZ/OZC/VCQ/VUK order books. If your firm has requested, all EBook orders (phone, wire, and electronic) and all ORS orders residing outside the book (booth or crowd routed) will be converted reflecting the adjustment. If your firm has requested, all EBook orders and ORS orders residing outside of the book will be canceled. If your firm receives EBook CXL drops, the CXL confirms will print at your booth at 3:15 p.m. ORS CXLs will also be transmitted electronically to your branches.

Immediately after the close, the book staff will return a final written report listing the orders that are converted or canceled to all firms. If converted, this list will also show how the new orders will be adjusted. This report will be available on request anytime during the day prior to the night of the adjustment.

Position and Exercise Limits

The CBOE Department of Market Regulation has determined that: "The position and exercise limits following this cash distribution will remain the same."
