

The **Cboe Europe All Companies** index is comprised of all the issuers resident in all Cboe Europe Single Country Indices regardless of the currency of issuers' primary listing. Issuers in Mid-Cap and Small Cap indices, e.g. Cboe DEM 50, Cboe UK 250 and Cboe UK Small Companies, are ineligible for inclusion in this index Base 10,000 - 31 Dec 2010. This is a price return index.

Objective

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

Investability

Stocks are selected and weighted to ensure that the index is investable.

Liquidity

Stocks are screened to ensure that the index is tradable.

Transparency

Uses a transparent, rules-based construction process. Index Rules are freely available on the cboe.com/indexeurope website.

Availability

Calculation is based on price and total return methodologies, both real-time, intra-second and end of day.

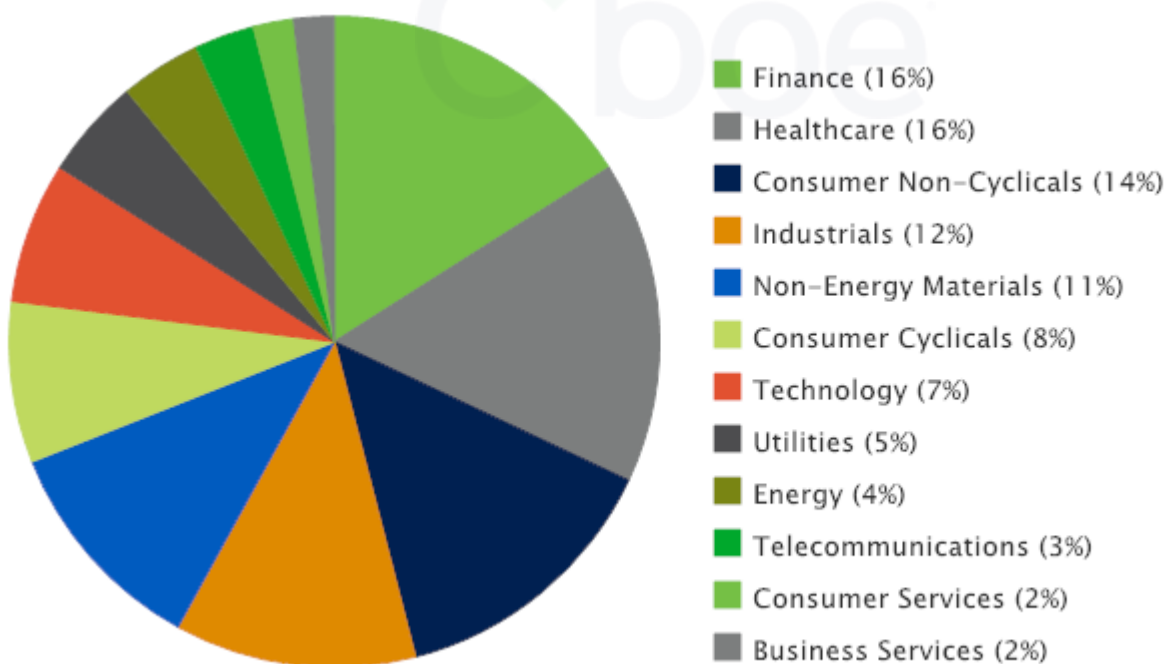
