

The **Cboe Eurozone All Companies** index is comprised of all the issuers resident in all Cboe Europe Single Country Indices in which the issuers are primary listed in Euro. Issuers in Mid-Cap and Small Cap indices, e.g. Cboe FRM 20 and Cboe DES 50, are ineligible for inclusion in this index. The index base level is 10,000 as of December 31st, 2010. This is a price return index.

Objective

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

Investability

Stocks are selected and weighted to ensure that the index is investable.

Liquidity

Stocks are screened to ensure that the index is tradable.

Transparency

Uses a transparent, rules-based construction process. Index Rules are freely available on the cboe.com/indexeurope website.

Availability

Calculation is based on price and total return methodologies, both real-time, intra-second and end of day.

Index constituents are classified by the FactSet Revere Business Industry Classification (RBICS) consisting of 12 anchor industries.

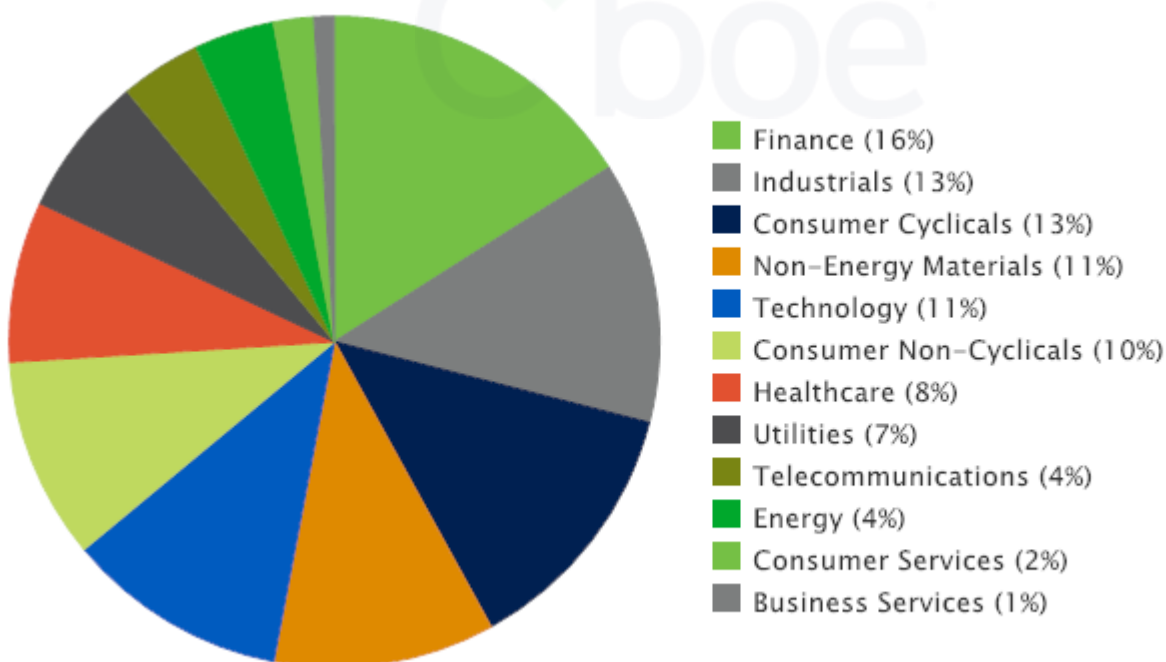
